1	Meeting called to order by Rosanne Williams at 18:02		
2	Quorum was present, committee proceeded with meeting.		
3	Safety Moment - Wanda Lyall spoke about all the changes that OH&S have been making in relation to mandatory training and how hard it is for non-profits to come up with funds for this training. She noted that after Fall Arrest training was completed she noticed around town how many people were working at heights and we not tied on. There seems to be no enforcement of OH&S guidelines.		
4	Rosanne Williams clarified that the Town of Happy Valley-Goose Bay withdrawal from the committee does not affect the function of the committee. Wanda mentioned that the Aboriginal groups also have not appointed anyone to sit on the committee and that one Member at Large seat was vacant. She wondered if all the empty seats would be filled. Rosanne indicated that an expression of interest for the vacant Member at Large seat would be issued at the end of the calendar year. The other seats are appointed by the Town of Happy Valley-Goose Bay and Aboriginal communities and will remain open for their participation.		
5	Meeting minutes dated June 18, 2013 were reviewed and approved.		
6	Rosanne Williams gave members a project update: • 300 person temporary camp operational • 275 currently in camp • 1,500 person main camp being installed

Powerhouse Contract

- Astaldi is the preferred contractor for the powerhouse contract
- Italian general contractor with over 90 years of global experience in the construction of large infrastructure projects in transportation, water and energy, and civil and industrial building.
- Astaldi will mobilize shortly and is looking to establish an office in HVGB in the coming weeks

Project Benefits

- Throughout August, 974 people were employed at Muskrat Falls. Of those:
 - o 85% (826) were residents of NL
 - 388 (~40%) were Lab. Residents; ~ 48% (186) are members of Lab. Aboriginal groups
 - Employment of Lab. residents rose ~21% over July; employment from Lab.
 Aboriginal groups grew ~16%
 - o 15% (148) were from outside the province
- August, total expenditures for the Muskrat Falls Project were over \$38 million.
 - o over \$27 million to NL businesses (72% of all project expenditures for August)
 - More than \$20.7 million of NL expenditures were spent on Labrador companies

Operations Employment

- Approximately 80 direct full time jobs in NL during the operational life of the Project.
 - o 40 Transmission
 - o 40 Muskrat Falls & Energy Control Centre, Corporate



Long Term Benefits

- Long-term stable electricity rates for generations
- Reliable, long-term supply of clean, renewable energy
- Energy independence an enviable position
- Energy for future mining and industrial development in the province
- Diversified economy, jobs and benefits
- Link to North America's electricity grid and ability to export power to other markets
- Long-term revenue generation

Discussion

- Daren Wells commented that he feels the community has a misconception about the role of the committee. The community thinks the committee can make decisions on investments into such items as a new arena and paving roads.
- Rosanne clarified that the role of the committee is to provide open, transparent
 communication and to have a two-way flow of information between the community
 and Nalcor. It is not in Nalcor's mandate to build local infrastructure; that is the
 responsibility of the provincial government. Nalcor does have a community
 investment program that supports many local organizations and events. If there are
 committees or groups looking for donations on initiates they need to present those to
 Matthew Pike.

7 Access to Wood

- Wood from the Labrador Marshalling yard will be available to the public
- The Department of Natural Resources is asking the public to call their office in North West River to find out when the wood will be available
- Anyone who would like to take wood will need a load slip from the DNR office in Goose Bay or North West River. The load slip is free.
- DNR will publically advertise when the wood is available to take. DNR is asking the public not to take wood until they advertise.
- Wood behind the site security gate on the south side of the river is the subject of an RFP, which is currently in the evaluation process
- The request for proposals has been reduced to two proponents. A letter will be sent to the two companies this month on a path forward.

8 Waste Disposal

- The camp has been self-sufficient and connected to the on-site sewage treatment facility since it opened.
- Some isolated or remote work sites (for example the security office at the main gate)
 are not connected into our system and were, and continue to be, collected by a waste
 management contractor for disposal. While all our waste from the camp is treated
 through our treatment facility, some waste was previously disposed in the Towns of
 Happy Valley-Goose Bay and North West River systems with approval from

	Safety of community and workers is #1 priority		
	All safety and regulatory protocols will be followed.

	 Hamilton River Road and TLH are owned and managed by the Province. 		
	HVGB has one regulation for oversized loads - flags are required.

	Leander stated that he felt the underlying issue with the Town of Happy Valley -		
	Goose Bay was that they have been trying to get Hamilton River Road (HRR) upgraded		
	and paved for years. Since 1965 all of Newfoundland has had paved roads and in		
	Labrador we still don't have paved roads.		
	Darren commented that part of the traffic issues on HRR can be attributed to the		
	base, where 350 employees leave to go home for lunch every day, which leads to		
	congestion and wear and tear.		
10	Hydro Rates

	RFI process in place to facilitate answering questions related to the GRA.

	•	Leander expressed his concern that there needs to be more public awareness about
		the CLC committee and who its members are.
	•	Matthew indicated this could be done through Facebook and the project website.
	•	Wanda wanted to know if there was a policy in place around workers living in Happy
		Valley Goose Bay. She noted that she has seen a large increase in social issues in the
		community, including lack of housing.
	•	Rosanne indicated that to her knowledge Nalcor does not have a policy. Nalcor has an
		on-site accommodations complex and does not provide any incentive for workers to
		stay in town.
	•	Wanda asked if a policy could be developed and if there are stats on how many
		workers are staying in town.
	•	Lorie, who sits on the camp committee, indicated that workers were placed in town
		due to overflow. She indicated that 30 rooms are to be opened by the end of
		November and 30 more every two weeks after. By the end of February, workers
	1	would be staying in camp.
	•	Rosanne stated there could potentially be some senior management stay in town.
